CABINET AGENDA ISSUES – 16 FEBRUARY 2015

The House is asked to note the following matters which were considered by the Cabinet at its meeting held on 16 February 2015:

- 1. Contracts;
- 2. Legislation Matters;
- 3. Annual Reports;

Each matter shall be elaborated on in turn.

1. Contracts

(i) Construction of Caymanas Sewage Conveyance System

Cabinet approved the award of a contract by the Urban Development Corporation to Y.P. Seaton & Associates Company Limited in the amount of J\$624,000,082.48 for the construction of the Caymanas Sewage Conveyance System at Caymanas, St Catherine.

The Urban Development Corporation is responsible for putting in place the necessary infrastructure in the Caymanas Estate Development Area for the benefit of developers who acquire segments of the 9,500 acre estate in accordance with the overall land use plan for the area. The infrastructure works include the construction of a sewage conveyance system from Caymanas Estate to the National Water Commission's operations at the Soapberry Sewage Treatment Plant.

(ii) Turn Key Cancer Treatment Centres

Cabinet approved the award of contract to Varian Medical Systems for the supply of equipment and construction of Cancer Treatment Centres at two (2) public health facilities, namely the Cornwall Regional Hospital and the St. Joseph's Hospital, in the sum of US\$14,465,747.10.

Given the epidemiological evidence confirming an increase in the incidence of certain cancers in Jamaica and the significant cost and human resource burden placed on the public health sector, there is a need to enhance efficiency and quality of care for cancer patients through improved technological options and protocols.

2. <u>Legislation Matters</u>

(i) The Property Tax (Amendment) Act, The Land Valuation (Amendment) Act, and The Tax Collection (Amendment) Act

Cabinet approved for tabling in the Houses of Parliament the three (3) Bills entitled "The Property Tax (Amendment) Act, 2015", "The Land Valuation (Amendment) Act, 2015", and "The Tax Collection (Amendment) Act, 2015".

The Bills seek to amend these Acts so as to expand the compliance and enforcement mechanisms available in law relating to property tax, including the introduction of a procedure for the sale of property in arrears for Property Tax.

(ii) The Income Tax (Amendment) Act

Cabinet gave approval for the introduction of the Bill entitled "the Income Tax (Amendment) Act, 2015" into the Houses of Parliament.

The Bill seeks to amend the Act in order to introduce a transfer pricing regime. This regime will provide Jamaica with a substantive and robust anti-avoidance mechanism to ensure its tax jurisdiction over cross-border activities.

3. Annual Reports

Cabinet considered the Annual Reports of the:

These Reports will be tabled in Parliament at a later date.
