**RFQ#2017/E004: SUPPLY OF COMPUTER HARDWARE FOR THE MINISTRY OF FINANCE AND THE PUBLIC SERVICE**

The details of the engagement are included in the Request for Quotation document which will be available for download as at **Monday, September 18, 2017** on the Government of Jamaica Electronic Procurement website ([www.gojep.gov.jm](http://www.gojep.gov.jm)). Registration is a prerequisite for Suppliers to participate in the Tender and therefore instructions (relating to registration) are available on the website.

**Procurement Method:** Local Competitive Bidding

**Source of Funding:** Project is funded by the Inter-American Development Bank under the Project No. JA-L1046. The Inter-American Development Bank (IDB) policy (GN-2349-9) and the Government of Jamaica (GOJ) Handbook of Public Sector Procurement Procedures, 2014 will guide the process.

**Compliance Certificates:** Jamaican nationals must submit a valid Tax Compliance Certificate (TCC) and a National Contracts Commission Certificate (NCC) with their bid.

The closing date for the submission of proposal is **Monday, October 2, 2017 at 2:00 p.m. (Jamaica Time)**. Online Bid Opening takes place thereafter on the same day (**Monday, October 2, 2017 at 2:15 p.m. (Jamaica Time)**). An online bid opening report will be sent to all Bidders that submitted a proposal.

**Late submissions will not be accepted.**

## REQUEST FOR PROPOSAL

### CONSULTANCY SERVICES TO UPDATE THE COST MODEL FOR MOBILE TERMINATION RATES

The Office of Utilities Regulation ("OUR") invites proposals from suitably qualified, experienced firms ("the Consultant"), to update the Long Run Incremental Cost Model (LRIC) used to determine the Mobile Termination Rates (MTRs) to be charged by telecommunications operators in Jamaica.

Bidding for the consultancy services will be conducted through the International Competitive Bidding procedures and is open to all bidders.

#### SCOPE OF WORK

1. Identify and assess all possible options for the update of the LRIC model. The Consultant is not expected to develop a new model, but instead to harness the relevant expertise required to critically assess if any of the elements in the existing approach to the development of the model, as well as within the model itself, warrants revaluation;
2. Undertake the required industry discussion and analysis to assess the current state of the industry and the existing regulatory environment;
3. Undertake consultations with interested stakeholders on any changes that are being proposed to the principles and methodology used to develop the current model with a view to recommend relevant modifications and enhancements to the model;
4. Prepare the draft consultation document;
5. Evaluate the comments received on the consultation document and prepare a response and a final document;
6. Update the LRIC model in line with the determined principles and methodology to calculate costs of interconnection; and
7. Train selected OUR staff members on how to use the updated model as well as conduct updates to the model in the future.

#### ELIGIBILITY

- Interested local firms must submit a valid Tax Compliance Certificate ("TCC") or Tax Compliance Letter ("TCL") issued by the Jamaican tax authorities with their Technical Proposal.
- Foreign firms, while not required to be in possession of the TCC/TCL at the time of bid submission, must provide a valid TCC/TCL at the time of contract signing.

Failure to adhere to these eligibility requirements will result in the disqualification of the bid.

Consultants will be selected in accordance with the procedures set out in the Government of Jamaica Handbook of Public Sector Procurement Procedures (March 2014) (the "Handbook") and is open to all eligible consultants.
