**DESCRIPTION OF WORKS:**

The contractor will be required to undertake the rehabilitation of road pavements inclusive of asphaltic double surface treatment, drainage improvement (culverts, kerb & channel) and some asphaltic concrete cross drains and surface patching.

**ELIGIBILITY FOR TENDER:**

Tenderers must provide: A valid Tax Compliance Certificate / Letter (TCC/TCL). A valid National Contract Commission (NCC) registration certificate indicating a **minimum Grade rating as outlined in the category of General Road Work**. A tender bond in the prescribed form, stamped by the Commissioner of Stamp Duty in the amount of not less than 2% of the total tender price or a managers/ certified cheque in the amount no less than 1% of the total tender price.

**COLLECTION OF DOCUMENTS:**

Tender documents will be available beginning **April 13, 2016**, between the hours of **10:0 a.m and 4:00 p.m** at the Offices of the Sugar Transformation Unit, Ministry of Industry, Commerce, Agriculture and Fisheries, Hope Garden, Kingston 6.

Tenderers will be required to pay a non-refundable fee of **\$4,000.00** for each document. Payment should be made in cash or manager's cheque to the "Permanent Secretary, Ministry of Industry, Commerce, Agriculture & Fisheries.
