SCOPE OF WORK

- To provide armed and unarmed Security Officers
- To provide Canine Service
- To provide supervision for Security Personnel on a 24-hr basis for premises located at
 - Head Office: 58a Half-Way Tree Road, Kingston 10
 - Television Department: Caenwood Centre, 37 Arnold Road, Kingston 5

Specific assignments will require the posting of Security Officers at pre-determined strategic locations as well as patrol, who will have responsibility to monitor all activities on the premises identified above and make daily reports on these activities.

ELIGIBILITY OF CONTRACTOR

- Present a valid Tax Compliance Certificate
- Submit Private Security Regulation Authority (PSRA) Certification for the company and security officers

- Submit a security of 1.5% of the Tender Sum
