CONSULTING SERVICES FOR HERMITAGE DAM REHABILITATION STUDY

THIS INVITATION FOR REQUEST OF EXPRESSIONS OF INTEREST SUPERSEDES THAT WHICH WAS PUBLISHED ON UNDB'S WEBSITE UNDER REFERENCE CDB44-05/15

The Government of Jamaica (GOJ) has received financing from the Caribbean Development Bank (CDB) towards the cost of the Hermitage Dam (HD) Rehabilitation Study and intends to apply a portion of the proceeds to eligible payments under a contract for which this invitation is issued. Payments by CDB will be made only at the request of GOJ and upon approval by CDB, and will be subject in all respects to the terms and conditions of the Financing Agreement. The Financing Agreement prohibits withdrawal from the financing account for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of CDB, is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations. No party other than GOJ shall derive any rights from the Financing Agreement or have any claim to the proceeds of the Financing.

The National Water Commission (NWC), the Executing Agency, now wishes to procure consulting services for the conduct of studies and the preparation of final designs and bidding documents for the rehabilitation of the Hermitage Dam.

The objective of the consultancy is to assist NWC in preparing recommendations and designs for a project to rehabilitate HD and to increase the capacity of the dam and to develop operational systems and procedures manuals and to enhance watershed management. The services to be provided for the development of project alternatives will include the assessment of the following: **structural; social and gender impacts; financial and economic costs and benefits; environmental impacts; climate vulnerability; construction risks; and transport, access and traffic management options. The services will also include the preparation of detailed designs, tender documents and cost estimates.**

NWC now invites interested eligible consulting firms to submit Expressions of Interest for the provision of these consulting services.

Consultants shall be eligible to participate if:

- (a) in the case of a body corporate, it is legally incorporated or otherwise organised in an eligible country, has its principal place of business in an eligible country and is more than 50 percent beneficially owned by citizen(s) and/or bona fide resident(s) of eligible country(ies) or by a body(ies) corporate meeting these requirements;
- (b) in the case of unincorporated firms, the persons are citizens or bona fide residents of an eligible country; and
- (c) in all cases, the consultant has no arrangement and undertakes not to make any arrangements, whereby any substantial part of the net profits or other tangible benefits of the contract will accrue or be paid to a person not a citizen or bona fide resident of an eligible country.

**All countries are eligible for this opportunity.**

In the assessment of submissions, consideration will be given to technical competence, qualifications and experience, local and regional experience on similar assignments, financial capability and existing commitments. All information must be submitted in English. Further information may be obtained from the first address below between the hours of **9:00 a.m. and 4:00 p.m. (Monday to Friday).**

One original and three hard copies of each submission must be received at the first address below no later than **4:00 p.m. local time on Wednesday, June 24, 2015** and one hard copy must be sent simultaneously to CDB at the second address below. The sealed envelope containing each submission should include the name and address of the applicant and shall be clearly marked **"EXPRESSIONS OF INTEREST: CONSULTING SERVICES – HERMITAGE DAM REHABILITATION STUDY – JAMAICA"**.

Following the assessment of submissions, a short-list of not less than three and not more than six applicants will be provided with full terms of reference and invited to submit technical and financial proposals to undertake the assignment. GOJ reserves the right to accept or reject late applications or to cancel this invitation partially or in its entirety. It will not be bound to assign any reason for not shortlisting any applicant and will not defray any costs incurred by any applicant in the preparation and submission of Expressions of Interest.
