Source of Funding: Project is funded by the European Union (EU) under the Project No. GRT/EX-14238-JA. The Inter-American Development Bank (IDB) policy (GN-2349-9) and the Government of Jamaica (GOJ) Handbook of Public Sector Procurement Procedures, 2014 will guide the process.

Compliance

Certificates: Jamaican nationals must submit a valid Tax Compliance Certificate (TCC) and a National Contracts Commission Certificate (NCC) with their bid.

The closing date for the submission of proposal is **Monday, October 10, 2016 at 1:00 p.m. (Jamaica Time)**. Online Bid Opening takes place thereafter on the same day (**on Monday, October 10, 2016 at 1:15 p.m. (Jamaica Time)**). An online bid opening report will be sent to all Bidders that submitted a proposal.
