University Hospital of the West Indies invites bidders to **purchase tender documents to supply pharmaceutical preparations**, as listed in the Schedule of Requirements of the tender documents, for a **24-month contract period**. Bidding will be conducted through the International Competitive Bidding (ICB) procedures specified in **the Government of Jamaica**, **Handbook of Public Sector Procurement Procedures http://www.mof.gov.jm** and is open to all bidders from all countries.

For tenders to be considered, bidders must submit the following:

- 1. Copy of valid National Contracts Commission (NCC) Certification in the category of 'Medical, Pharmaceutical Equipment and Supplies'. Overseas bidders are required to submit proof of registration with the NCC prior to award
- of contracts and are invited to visit the NCC website at **www.ncc.gov.jm** for registration instructions.
- 2. Copy of valid Tax Compliant Certificate (TCC).
- 3. Bid security in the amount of Three Thousand United States dollars (US\$ 3,000.00) or its Jamaican equivalent using conversion rate of US\$1:JA\$120.00. The bid security shall be in the form of a Bank Manager's cheque payable to the University Hospital of the West Indies, or an unconditional banker's guarantee or bid bond.
- 4. A completed and signed Bid Form.
- 5. A copy of the Ministry of Health's (Jamaica) Pharmaceutical Product Licence for all pharmaceutical preparations offered.
- 6. Relevant pharmaceutical samples: one sample in the package size being tendered, for pharmaceutical preparations not previously supplied to the University Hospital of the West Indies. For each Intravenous (IV) Fluid being tendered, six samples must be submitted.
- 7. Manufacturer's Authorization where applicable.
- 8. Testimonials where applicable: All suppliers, not previously awarded contracts for the supply of pharmaceutical preparations, shall furnish documentary evidence, as to prior experience and ability to perform. The testimonials should be from at least three institutions with whom the tenderer has successfully executed contracts for similar products and should indicate the tenderer's prior experience and ability to perform. No contract will be entered into with a tenderer who fails to submit such testimonials, where applicable, on request, or submitting testimonials deemed by the Procuring Entity to be inadequate.

Interested eligible bidders may purchase the bidding documents for a nonrefundable fee of **US\$60.00** (or its Jamaican equivalent using the conversion rate of **US\$1:JA\$120.00**), at the address below, between **9:00 a.m. and 4:00 p.m.** commencing **Thursday**, **February 11**, **2016**.


