The project intends to apply part of the loan proceeds to payments under the contract for the following consultancy service:

The overall objective of each Consultancy is to develop and deliver an eighteen-month programme of education and training interventions to a group of **25-30 Steps to Work clients, between the ages of 16 and 25 years to ensure their certification (grades 1 to 3) in at least five core subjects including Mathematics and English in the Caribbean Secondary Education Certificate (CSEC) and NCTVET Level II or equivalent certification in one (1) marketable Vocational Skill.**
