- A valid National Contracts Certificate (NCC) registered in the category of **Safety and Security Services**
- Registration/Licence from the Private Security Regulation Authority (PSRA)
- Proof of adequate Liability Insurance coverage
- Bid Security representing 2% of the contract sum is required with the submission of bids

Tenders that do not contain all of the above on opening will be deemed non-responsive.
