REQUEST FOR EXPRESSIONS OF INTEREST

The Government of Jamaica (GOJ) has received financing from the Caribbean Development Bank (CDB) – United Kingdom Caribbean Infrastructure Partnership Fund (UKCIF), in an amount equivalent to £35,515,000 towards the cost of the **Essex Valley Agriculture Development Project (EVADP)** and intends to apply a portion of the proceeds to eligible payments under a contract for which this invitation is issued. Payments by CDB will be made only at the request of GOJ and upon approval by CDB, and will be subject in all respects to the terms and conditions of the Financing Agreement. The Financing Agreement prohibits withdrawal from the financing account for the purpose of any payment to persons or entities, or for any import of goods, if such payment or import, to the knowledge of CDB, is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations. No party other than GOJ shall derive any rights from the Financing Agreement or have any claim to the proceeds of the Financing.

The **Ministry of Industry, Commerce, Agriculture and Fisheries (MICAFA)** the Executing Agency, now wishes to procure consultancy services to conduct a **Cost of Service and Tariff Study for the National Irrigation Commission Ltd.** (NIC) The NIC is responsible for the management, control and operation of GOJ owned and operated irrigation schemes.

The objective of the assignment is to assist the NIC in the development of a cost recovery model which ensures that charges levied for the supply of irrigation water and related services provide for reasonable cost recovery while simultaneously providing incentives for efficiency improvements at the level of NIC and its clientele.

The duration of the assignment is expected to be for a period of thirty (30) weeks.

MICAFA now invites interested eligible consulting firms to submit Expressions of Interest for the provision of these consultancy services.

Consultants shall be eligible to participate if:

- (a) In the case of a body corporate, it is legally incorporated or otherwise organised in an eligible country, has its principal place of business in an eligible country and is more than 50 per cent beneficially owned by citizen(s) and/or bona fide resident(s) of eligible country(ies) or by a body(ies) corporate meeting these requirements;
- (b) In the case of unincorporated firms, the persons are citizens or bona fide residents of an eligible country;
- (c) In all cases, the consultant has no arrangement and undertakes not to make any arrangements, whereby any substantial part of the net profits or other tangible benefits of the contract will accrue or be paid to a person not a citizen or bona fide resident of an eligible country; and

Specifically, the consulting firm should be very familiar with conducting medium to large-scale cost-of-service and tariff studies for the water sector, specifically for irrigation and must have substantial professional experience in facilitation services, strategic business planning, business-process improvement, information needs analysis, and gender and social analysis.
