The Government of Jamaica (GOJ) has received loan financing from the International Bank for Reconstruction and Development (IBRD) towards the cost of the Strategic Public Sector Transformation Project (SPSTP) and intends to apply part of the proceeds for the consulting services. The Project Development Objective (PDO) is to strengthen public resource management and support selected public sector institutions in facilitating a more enabling environment for private sector growth.

The PIMIS Application Administrator will provide on-the-ground/on-call application administrative support services to facilitate the introductory implementation and use of the Public Investment Management Information System (PIMIS). The Application Administrator is intended to provide support services as the PIMIS may have adaptation issues and/or bugs which are common with the introduction of new systems that need to be tailored/customised for the particular end-user functional and non-functional requirements. The consultancy will have a duration of **twelve (12) months**.

The Ministry of Finance and the Public Service now invites eligible individuals to indicate their interest in providing the consultancy service. Interested individuals should provide information demonstrating that they have the required qualifications and relevant experience to perform the service. The shortlisting criteria are:

- Associate Degree in Computer Science or equivalent qualification;
- Knowledge of UNIX, Microsoft Server & JAVA platform;
- Minimum 5-8 years operating as an administrator of a system with 100 or more simultaneous users.

The attention of interested Consultants is drawn to Section III, paragraphs, 3.14, 3.16, and 3.17 of the World Bank's "Procurement Regulations for IPF Borrowers" July 2016, Revised November 2017 ("Procurement Regulations"), setting forth the World Bank's policy on conflict of interest.

FOR SERVICES COMMISSIONING AGENT AT THE CORNWALL REGIONAL HOSPITAL REHABILITATION PROGRAMME

Cornwall Regional Hospital (CRH) is in Mount Salem, Montego Bay which is two miles from the Montego Bay city centre. The Hospital is a 10-storey building with a 400-bed capacity that was built in 1974. CRH is the only Type A hospital providing specialist services to the county of Cornwall (Westmoreland, Hanover, St. Elizabeth, St. James and Trelawny).

The hospital was built with natural air ventilation. However, the 1st to 5th floors were subsequently fitted out with central air conditioning. Approximately 25 years ago, these central air systems were updated to ensure adequate cooling of the spaces using split air conditioning units. The original ducting system was never removed nor comprehensively rehabilitated.

The Ministry of Health & Wellness now invites eligible individual/firm consultants to submit proposal for the provision of **COMMISSIONING AGENT SERVICES FOR THE CORNWALL REGIONAL HOSPITAL REHABILITATION PROGRAMME.**

The requirements are:

The Commissioning Agent (CxA) must have a technical background and an in-depth expertise with the commissioning process including verification techniques, functional performance testing, system equipment and O&M knowledge.

1. The CxA must be a member of the AABC Commissioning Group (ACG) or a similar organization with a Certified Commissioning Authority (CxA) programme that has achieved at minimum accreditation by the American National Standards Institute (ANSI).
 - a. The CxA must have on staff Certified Commissioning Technicians (CxTs) to provide support to the CxA.
2. The CxA must have documented commissioning process experience on at least two building projects with a similar scope of work in the Health Sector.
 - a. The experience must extend from early design phase through at least 10 months of occupancy.
3. The CxA must be an independent consultant, or an employee of the design or construction firm who is not part of the project's design or construction team, or a disinterested subcontractor of the design or construction team.

REQUIREMENTS

The successful Individual/Firm is required to obtain a Tax Compliance Certificate (TCC) from Tax Administration Jamaica, Government of Jamaica upon contract award.

Update of Jamaican Taxation Registration Number (TRN) and Tax Compliance Information for participation in GOJ tender opportunities via the Electronic Procurement System:

All suppliers that have a Jamaican based Taxation Registration Number (TRN) are being asked to validate their TRN and Tax Compliance information (TCC/TCL) on the Government of Jamaica Electronic Government Procurement (GOJEP) System.

The purpose of a valid TRN in GOJEP is to:

- I. Verify supplier's details;
- II. Allow for retrieval of Tax Compliance information for Supplier and;
- III. Facilitate the integration of the e-Tendering (GOJEP) System with Supplier's information in the Government's National Contract Commission (NCC) registration system using the suppliers TRN as shared identifier between both systems.

To update your Organization's TRN and Tax Compliance data in the e-Tendering system, Supplier Admin Users must execute the following steps:

- I. Log in to the System (www.gojep.gov.jm);
- II. Select the Supplier management link (under the Supplier Administration section on the left);
- III. Select the Edit organisation link/button;
- IV. For the Taxation Registration Number (TRN) prompt – Enter your organization's nine (9) digit TRN (no space or dashes). See TRN rules below;
- V. For the Taxation Compliance Reference (TCC/TCL) # prompt – Enter the last TCC# issued to your Organization by the Tax Administration Jamaica (TAJ), if one was issued. By completing this task:
 - a. Your Organization's Taxation Compliance Expiration Date information will be retrieved from the TAJ Taxation system and displayed on your Organization's record in GOJEP;
 - b. Tax eligibility information for your Organization will print on the Tender Opening Reports generated by the system;
 - c. The System will send you an email reminder, fourteen (14) days prior to the expiration of your Organization's tax compliance status. Upon the expiration and renewal of your Tax Compliance, please ensure same is updated in the system by following the above steps.
- VI. Select the Save button once you have entered the above information.

Sole Trader or Trading As Entity	100009999/0001	TRN must begin with the digit 1 and must be nine digits. A sub 4 digit number must be entered, example 0001 or 0002 or 0003 etc. No '-' or space shall be entered
Individual Consultant	100009999	TRN must begin with the digit 1 and must be nine digits. No sub 4 digit number must be entered, No '-' or space shall be entered
