The Jamaica Social Investment Fund (JSIF) intends to award works contract(s) for the **Adelphi Health Centre Construction (Lot 1) St. James, Jamaica; Barrett Town Health Centre Expansion (Lot 2), St. James, Jamaica; Flanker Health Centre Expansion and Rehabilitation (Lot 3), St. James, Jamaica; Granville Health Centre Expansion and Rehabilitation (Lot 4), St. James, Jamaica** with financial assistance from the EU Poverty Reduction Programme (PRP IV).

Lot 1: ADELPHI HEALTH CENTRE CONSTRUCTION – ST. JAMES (#073337)
The scope of work includes but is not limited to the construction of consultation rooms, public health offices, registration and records room, waiting room, lunch room/kitchenette, staff and public bathrooms, pharmacy, dressing and treatment room, perimeter fencing etc. **Construction period is six (6) months.**

Bids MUST be accompanied by Bid Security in the amount of Four Hundred and twenty Thousand Jamaican Dollars (J\$420,000.00).

Lot 2: BARRETT TOWN HEALTH CENTRE EXPANSION – ST. JAMES (#073382)
The scope of work includes but is not limited to the construction, expansion and rehabilitation of consultation room, office, records room, waiting room, kitchen, staff and public bathrooms and perimeter fencing etc. **Construction period is six (6) months.**

Bids MUST be accompanied by Bid Security in the amount of Three Hundred Fifty Thousand Jamaican Dollars (J\$350,000.00).

Lot 3: FLANKER HEALTH CENTRE EXPANSION AND REHABILITATION – ST. JAMES (#073343)
The scope of work includes but is not limited to the construction, expansion and rehabilitation of consultation rooms, offices, registered nurse/midwife offices, treatment and dressing rooms, public health office, lunch room/kitchenette, registration and records area, waiting area, restrooms, driveway and parking area, perimeter fencing etc. **Construction period is six (6) months.**

Bids MUST be accompanied by Bid Security in the amount of Three Hundred Eighty Thousand Jamaican Dollars (J\$380,000.00).

Lot 4: GRANVILLE HEALTH CENTRE EXPANSION AND REHABILITATION – ST. JAMES (#073492)
The proposed scope of work includes but is not limited to construction, expansion and rehabilitation of dental office, medical records office, restrooms, dressing room, sterilization room, treatment room, public health offices, consultations rooms, pharmacy, waiting area, laundry and storage area, offices, perimeter fencing etc. **Construction period is six (6) months.**

Bids MUST be accompanied by Bid Security in the amount of Three Hundred and Ninety Thousand Jamaican Dollars (J\$390,000.00).

Bidding will be conducted in accordance with tender procedures and guidelines specified in the Grant Contract 2013/024-834 External Actions of the European Community – Contract Award Procedures of the European Community.
