The Ministry of Justice invites eligible and qualified Contractors to submit bids for the above-stated Project.

ELIGIBILITY OF CONTRACTORS

To be considered eligible, at the time of tender opening your tender must include the following:

- Proof of valid registration with the Public Procurement Commission (PPC), in the Category: Building Construction - Grade 1 (minimum)
- Copy of a valid Tax Compliance Certificate (TCC)

Non-compliance with all or any of the two criteria above will result in an automatic disqualification of tender.

SCOPE OF WORKS

The works involve the expansion of the functions of the existing court spaces to include the construction of two new buildings and the associated horizontal construction, mechanical and electrical services to allow for the functioning of a family court. The vertical construction will involve traditional concrete as well as horizontal construction of parking and drainage facilities. The mechanical and electrical works will also include the installation of pumps, plumbing, water storage, air conditioning, and electrical systems to allow for the full functionality of the operations of the courts. The new construction will complement the existing structure which will be incorporated into the overall functions of the court.
