No offline (hard copies) will be accepted and there will be no physical tender drop-off of tender documents.

- Clarification period- no later than 7 working days (Thursday, February 27, 2020) before bid submission deadline.

Submission deadline: Tenders must be submitted by via GOJEP no later than Thursday, March 5, 2020 at 11:00 a.m.
