The National Works Agency invites eligible contractors to submit tenders for **SEAMAN'S VALLEY – ALLIGATOR CHURCH BRIDGE (SEAMAN'S VALLEY – MILL BANK), LOCATED IN THE PARISH OF PORTLAND**. The works consist of but not limited to demolition and site clearance, install HDPE pipe culvert 600mm diameter, pavement works such as base course, prime coat and asphaltic overlay (38mm thick) and ancillary road works such as kerb and channel.
