THE DISASTER RISK MANAGEMENT ACT

THE DISASTER RISK MANAGEMENT (ENFORCEMENT MEASURES) (No. 2) ORDER, 2020

WHEREAS the Minister responsible for disaster preparedness and emergency management has given written notice to the Prime Minister that Jamaica appears to be threatened with or affected by the SARS - CoV-2 (Coronavirus COVID-19), and that measures apart from or in addition to those specifically provided for in the Disaster Risk Management Act should be taken promptly:

AND WHEREAS on the 13th day of March, 2020, the Prime Minister by Order declared the whole of Jamaica to be a disaster area:

Now therefore:

In exercise of the powers conferred upon the Prime Minister by section 26(2) of the Disaster Risk Management Act, the following Order is hereby made:—

1. This Order may be cited as the Disaster Risk Management (Enforcement Measures) (No. 2) Order, 2020.

- 2. With effect from the 25th day of March, 2020, the measures set out in this Order are directed to be enforced for removing or otherwise guarding against or mitigating the threat, or effects, of the SARS CoV-2 (Coronavirus COVID-19) and the possible consequences thereof.
- 3.—(1) For the period from the 25th day of March, 2020, to the 7th day of April, 2020, no person shall be permitted to enter Jamaica.
- (2) Sub-paragraph (1) shall not apply to any person, or category of persons, authorised by the Minister responsible for immigration, subject to the approval of the Cabinet.
- (3) Each person landed in Jamaica between the 18th day of March, 2020, and the 21st day of March, 2020, from any country where there is local transmission of the SARS CoV-2 (Coronavirus COVID-19), as published by the Ministry responsible for health and wellness from time to time, is required to remain within that person's abode or place of residence for the period from the 25th day of March, 2020, to the 7th day of April, 2020.
- (4) A person referred to in sub-paragraph (3) shall comply with the quarantine rules as outlined by the Ministry with responsibility for health and wellness, whether the abode or place of residence referred to that paragraph is a hotel or not.
- (5) A person referred to in sub-paragraph (3) shall be permitted to leave Jamaica before the 7th day of April, 2020, if the person does not have any symptoms of the SARS CoV-2 (Coronavirus COVID-19).
- (6) If during the period referred to in sub-paragraph (3) a person develops symptoms of the SARS CoV-2 (Coronavirus COVID-19), the person is required to forthwith inform the Ministry with responsibility for health and wellness.
- (7) A person who, after the 21st day of March, 2020, has been permitted to enter Jamaica, shall—
 - (a) remain in quarantine, at that person's abode or place of residence, or such other place as may be directed by an authorized officer, for a period of 14 days beginning from the date on which that person was permitted to enter Jamaica; and
 - (b) comply with all applicable directions given, and requirements imposed, by an authorized officer.
- 4. A person in Jamaica who develops flu-like symptoms and who may have had contact with someone who—
 - (a) has travelled to a country affected by the SARS CoV-2 (Coronavirus COVID-19); or
 - (b) is infected with the SARS CoV-2 (Coronavirus COVID-19) or has been exposed to a person so infected,

is required to forthwith inform the Ministry with responsibility for health and wellness.

- 5.—(1) Except as required for attendance at work in accordance with paragraph 6, for the period from the 25th day of March, 2020, to the 7th day of April, 2020, gatherings in any public place shall not exceed 10 persons at a time, and each person at such a gathering shall maintain a distance of at least 91.44 centimetres (or 3 feet) from other persons.
 - (2) Sub-paragraph (1) does not include—
 - (a) subject to sub-paragraphs (3)(a) and (4), hospitals, infirmaries and nursing homes;
 - (b) the Jamaica Constabulary Force and the Jamaica Defence Force;
 - (c) services concerning the provision of health, water, electricity, sanitation, firefighting, civil aviation, or telecommunications;
 - (d) correctional services;
 - (e) tourist establishments, as defined in the Public Health (Tourist Establishments) Regulation, 2000;
 - (f) subject to sub-paragraph (3)(b), retail services (such as markets, supermarkets, pharmacies and "corner shops") for the provision of food, medicine or other necessities of life;
 - (g) sittings of the Houses of Parliament, and meetings of the Cabinet, or any committees thereof:
 - (h) Ministries, Departments and Agencies of Government, and Municipal Corporations;
 - (i) Tax Administration Jamaica, the Bank of Jamaica and the Jamaica Customs Agency;
 - (j) banking business, as defined in the Banking Services Act;
 - (k) services connected with oil-refining and with the loading, distribution, transportation or retail of petroleum fuel, liquefied natural gas or any renewable energy source;
 - (l) services connected with the loading and unloading of ships and with the storage and delivery of goods at, or from, docks, wharves and warehouses operated in connection with docks or wharves;
 - (m) the provision of public transportation by bus (including buses operated by the Jamaica Urban Transit Company or the Montego Bay Metro Company Limited), limited to seated passengers only;
 - (n) the provision of public transportation by motor car, limited to one person less than the maximum number of persons allowed to be carried under the relevant licence;
 - (o) the Judiciary and persons employed to a court;

- (p) any service, activity or public gathering, authorised to be carried on by the Medical Officer (Health), or a person designated by the Medical Officer (Health) to give such authorisation.
- (3) During the period referred to in sub-paragraph (1)—
- (a) the operator of a hospital or nursing home shall ensure that no person visits a patient in the hospital or nursing home, more than once per day, and that each such patient does not have more than one visitor per day; and
- (b) markets shall operate only during the hours of 6:00 am to 2:00 pm.
- (4) During the period from the 25th day of March, 2020, to the 23rd day of April, 2020, the operator of an infirmary shall ensure that—
 - (a) no person visits, more than once per day, a patient in the infirmary and that each such patient does not have more than one visitor per day; and
 - (b) no patient of the infirmary is permitted to go outside the infirmary.
- (5) With effect from the 25th day of March, 2020, to the 23rd day of May, 2020, no new patient shall be admitted to an infirmary.
 - 6.—(1) For the period from the 25th day of March, 2020, to the 7th day of April, 2020—
 - (a) no person employed to the Government who has attained the age of 65 years or more, other than persons—
 - (i) employed in any undertaking or entity referred to in any of paragraphs 5(2)(a), (b), (c), (d), (g), (h), (i), (k) (l) or (o); or
 - (ii) authorised under paragraph 5(2)(p),

shall be required to attend at the person's place of employment and shall, to the extent possible, work from home; and

- (b) all other persons who can work from home should do so.
- (2) During the period referred to in sub-paragraph (1), an employer shall have a duty, if satisfied that an employee is able to discharge the duties of that employee from the employee's place of residence, to grant the employee permission to do so without imposing any adverse consequences to the employee in respect thereof.
- (3) An employee whose assigned tasks can only be discharged at the place of employment is required to attend for work at that place during the period referred to in sub-paragraph (1) unless otherwise permitted by the employer as part of the employer's measures to combat the risk of transmission of the SARS-CoV-2 (Coronavirus COVID-19) at the place of employment.

- (4) The grant of permission to an employee under sub-paragraph (2) or (3) shall not count against the leave entitlements of that employee, unless otherwise agreed between the employer and employee.
- 7.—(1) Notwithstanding the provisions of paragraph 6, a person who has attained the age of 75 years or more shall remain within that person's abode or place of residence, except that the person may once per day leave that abode or place of residence for food, medicine or other necessities of life.
- (2) Sub-paragraph (1) shall not apply to any person employed in any undertaking or entity referred to in paragraph 5(2)(g) or (h), or in any service or activity authorised under paragraph 5(2)(p).
- 8.—(1) For the period from the 25th day of March, 2020, to the 23rd day of April, 2020—
 - (a) all bars, nightclubs and other places of amusement shall remain closed;
 - (b) the opening hours of barber shops and hair salons shall be no earlier than 10:00 am and no later than 5:00 pm;
 - (c) no more than 10 persons at a time shall be permitted to be in any barber shop or hair salon, and no more than 2 of those persons shall be clients waiting to be served.
- (2) In sub-paragraph (1), "place of amusement" means any place open to the public, whether for a fee or free of charge, for the purpose of entertainment and (without limit to the generality of the foregoing) includes a cinema, dance hall, club, open air dance venue, amusement arcade, any place where a coin operated amusement machine is open to the public, a festival, discotheque, roller disco, or skate rink.
- 9. Every educational institution, as defined in the Education Act, shall remain closed until the 19th day of April, 2020.
- 10. The Disaster Risk Management (Enforcement Measures) Order, 2020, is revoked. Dated this 24th day of March, 2020.
