Late bids will be automatically rejected by the system.

CONSULTANT SERVICES TO CONDUCT 2021 KNOWLEDGE, ATTITUDE, BEHAVIOUR AND PRACTICE (KABP) SURVEY

The Ministry of Health & Wellness/HIV/STI invites sealed bids from eligible and qualified consultants to conduct a Knowledge Attitude Behaviour and Practices (KABP) Survey with regard to HIV/AIDS in adults aged 15-49 years in Jamaica.

The adult HIV prevalence in Jamaica stands at 1.5% with an estimated 32, 617 PLHIV (revised UNAIDS estimates, 2019). The National HIV/STI Programme (NHP) has since 1991 conducted KABP studies in Jamaica in an effort to understand the knowledge, attitude, behaviour and practices of the general population towards HIV/AIDS and among concentrated populations who practise high risk-behaviour. The findings will assist in directing the Programme's prevention, treatment and enabling resources to key areas in tackling HIV/AIDS.

Eligibility Requirements

Consultants must submit the following with their proposal at the time of bid submission:

- Valid Tax Compliance Letter (TCL)/Tax Compliance Certificate (TCC) and all other requirements contained in the Tender Document.
