The Culture, Health, Arts, Sports and Education (CHASE) Fund now invites sealed bids from eligible **CONTRACTORS** for the proposed "**Construction**" of the following institution:

- **Olympic Way Community Cultural Centre – 119 Olympic Way, Kingston**

DESCRIPTION OF WORKS

- **Olympic Way Community Cultural Centre – 9 months**
Construction of a multipurpose building of approximately 6300 sq ft consisting of a main hall to accommodate plays, cultural events, boxing matches, etc., changing room, bathroom facilities, storage room, meeting room, etc.

ELIGIBILITY:

It is mandatory that contractors be registered with the Public Procurement Commission in the category of "Building Construction" **Grade 1**.

All bidders must be **Tax Compliant** at the bid opening. Bidding will be in accordance with tender procedures and guidelines specified in the Revised Handbook of Public Sector Procurement Procedures (March 2014).

AVAILABILITY OF BID DOCUMENTS:
