The Ministry of Justice (MOJ) invites eligible Contractors to submit bids for the above-stated Project.

ELIGIBILITY CRITERIA OF CONTRACTORS

To be considered eligible, at the time of tender opening your tender must include the following:

SCOPE OF SERVICES

The Consultant will be required to provide appropriate and fit for purpose designs, financial and social feasibility assessments, cost estimates, tender and evaluation support, contract preparation and contract administration until the project has been completed. Consultants will undertake the designs for all elements outlined in the attached schedule of accommodation; not exceeding 7,803 sq. m. (84,000 sq. ft.) and 2,787.9 sq. m. (30,000 sq. ft.) for the car park. The complex will be developed on a phased basis. The scope of services for this tender is for Phase 1 which consists of the following:

- All designs for the Regional, Parish and Family Courts (7,803 sq. m./84,000 sq. ft.) and Car Park (2,787.9 sq. m. /30,000 sq. ft.)
- Construction Management for the Regional/Parish Court (6,689 sq. m.) and car park.
