In keeping with the Government's commitment to strengthen and promote Public Procurement, the Ministry of Finance and the Public Service (MOF&PS), Office of Public Procurement Policy (OPPP) is on a drive to expand the use of the Government of Jamaica Electronic Procurement System (GOJEP) to its suppliers of goods, services and works. This is in keeping with the commitment of the Government to all procurement opportunities published and managed through GOJEP.

Suppliers are being urged to register their businesses in GOJEP and take advantage of the free training sessions facilitated by the Ministry of Finance and the Public Service in the use of the system during the month of August.

Description of Service: By way of International Competitive Bidding, the National Water Commission (NWC) is inviting local and international firms, with strong capabilities, experience and qualified personnel in Chemicals and Pesticide to undertake the supply and delivery of Liquid Chlorine to various NWC locations throughout the Island for the period 2021-2024 (3 years supply)

Eligibility Requirements:

Tenderers must submit:

- A valid Tax Compliance Certificate (TCC)/valid Tax Compliance Letter (TCL) prior to the award of contract
 - A valid registration certificate from the Public Procurement Commission (formerly NCC) in the category of Chemicals and Pesticides, prior to the award of contract.
 - Completed, signed and sealed form of tender
 - A Power of Attorney (POA) document is required if the Company's bid is not signed by a Director or Chief Executive Officer of the company.
- For International Firms:** the Power of Attorney document should be drafted, signed/verified, stamped and registered by the relevant authorities in their respective countries.

Additional requirements are outlined in the Criteria used for evaluation in the Bidding Document.

Availability of Bid document and Bid Submission: This is an online tender where tender documents, clarifications and bids will only be made available and accepted via the Government of Jamaica Electronic Procurement Portal-GOJEP (www.gojep.gov.jm). No offline (hard copies) will be accepted and there will be no physical tender drop-off of tender documents.

- Tender documents can be downloaded as of **Thursday, January 28, 2021.**
- Clarification period – no later than 7 working days (**Monday, March 1, 2021**) before the bid submission deadline.

Submission deadline: Tenders must be submitted by via GOJEP no later than **Wednesday, March 10, 2021 at 11:00 a.m.**

Late bids will be automatically rejected by the system.

The original Bid Security MUST be submitted in hard copy to the Tender Box at the National Water Commission (NWC) and delivered by **Thursday, March 11, 2021 at 11:00 a.m.** at the following address:
