SUPPLY AND DELIVERY OF ONE (1) WATER TRUCK

The National Irrigation Commission Limited (NIC) invites eligible Bidders/Suppliers to submit bids for the procurement opportunity – the Supply and Delivery of one (1) Water Truck. Procurement of this water truck will increase the existing fleet of water trucks, allowing the NIC to target potential customers in areas not currently being served by irrigation systems.
