The Ministry of Science, Energy and Technology (MSET), acting on behalf of the Government of Jamaica, has received financing from the Inter-American Development Bank (IDB), Japan International Cooperation Agency (JICA) and European Union Caribbean Investment Facility (EU-CIF), and intends to apply part of the proceeds to payments under the project Energy Management and Efficiency Programme (EMEP) for consultancy services. Bidding will be governed by the Inter-American Development Bank's and the European Union eligibility rules and procedures.

The MSET, the executing agency for the project now invites eligible consulting firms who are nationals of member countries of the IDB and/or eligible European Union countries to indicate their interest in undertaking the consultancy: **Diagnostic Study on MSET ICT system for the Integration of all Power Systems Tools used in the Electricity Sector**. Interested Consultants should provide information demonstrating that they have the relevant experience to support this consultancy.

A consulting firm will be selected in accordance with the International Competitive Bidding (ICB) method in accordance with the procedures set out in the Inter-American Development Bank's: **Policies for the Selection and Contracting of Consultants financed by the Inter-American Development Bank** GN-2350-9, the EU Rules on participation in procurement procedures and grants (PRAG) annex A2a and the Government of Jamaica (GOJ) Public Sector Procurement Procedures, and is open to all eligible and qualified bidders as defined in the Inter-American Development Bank policies and the European Union eligibility rules and procedures. Consulting firms eligible to participate are those who are nationals of member countries of the IDB and or the EU Eligible countries.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. For the purpose of establishing the shortlist, the nationality of a firm is that of the country in which it is legally incorporated or constituted and in the case of Joint Venture, the nationality of the firm appointed to represent it.
