The National Irrigation Commission Limited (NIC) invites eligible Bidders/Suppliers to submit bids for the procurement opportunity – the Supply and Delivery of one (1) Telescopic Boom Crane Truck. Procurement of this crane truck will improve service delivery for the NIC in the lifting of industrial equipment/components when undertaking repairs and new installation works on the NIC's irrigation infrastructure.

1. ELIGIBILITY REQUIREMENTS:
