### INVITATION TO BID

The Jamaica Social Investment Fund invites eligible applicants to submit bids for Civil Infrastructure Works - **Anchovy Integrated Infrastructure Project, St. James.**

#### Scope:

The scope of works involves Installation of approximately 9.8km of 200mm diameter D.I. pumping transmission main from Shettlewood Springs to Montpelier, and from Montpelier to Mount Carey relift station. The installation of 2.0km of 150mm diameter D.I pumping transmission main from Mount Carey relift station to the existing Nelson storage tank (100,000 gallons) in Comfort Hall. The Nelson Tank is to be refurbished as it is the main storage facility. The access road to the Nelson tank will also be rehabilitated. The scope also includes full reinstatement of the roadway associated with these transmission mains. The scope also includes the supply and installation of 2 pumps at Shettlewood Springs, and also 2 pumps at the Mount Carey Lift Station. The electrical works associated with the installation of these pumps are also included. A motor control centre is to be constructed with additional electrical and mechanical work to support the system. Construction period is twelve (12) months.
