Vision 2030 Jamaica was developed with the primary objective of providing a strategic framework to advance the achievement of developed country status towards ensuring a secure and prosperous future for all Jamaicans. The Government of Jamaica (GOJ) has received financing from the World Bank towards the cost of the Strategic Public Sector Transformation Project (SPSTP), and intends to apply a part of those proceeds towards the cost of engaging a consulting firm to Conduct Review and Update of the 28 Vision 2030 Jamaica-Sector Plans.

The Ministry of Finance and the Public Service now invites eligible firms to submit their Expressions of Interests (EOIs) in providing the consultancy service. Interested firms should provide information demonstrating that they have the required qualifications and relevant experience to perform the service. Required qualification and experience include:

- At least 5 years' experience in national development planning on similar type assignments for GOJ or elsewhere in the Caribbean Region;
- Minimum 3 years' experience in research of a similar nature:

Key Experts will not be evaluated at the shortlisting stage.
