Key to this transformation is the creation of a well-defined corporate identity that reflects a modern and unique organization that is creating value for all stakeholders through the provision of data for national development. - An online bid opening will take place on **July 26, 2021 at 3:15 p.m.**
- Deadline for Clarification: All clarifications should be submitted on or before **July 12, 2021 at 3:00 p.m.** via the electronic portal.
