Housing Agency of Jamaica Limited (HAJL) invites a Commissioned Land Surveyor with suitable experience and resources to submit a proposal for the Provision of Topography Survey and Boundary Plan for Lands Part of Grange Pen Greenfield Site, St. James.

SCOPE OF SERVICE

The Commissioned Land Surveyor is expected to conduct a detailed Topographical Survey and Boundary Plan of the property earmarked for development using maximum transverse lines of 15m by ground survey. The surveyor is also expected to conduct a detailed research of the exact location of the boundary for the parcel of land shown on the plan which comprises the 241 acres.
