The NCC works with various agencies across Government to identify, implement and monitor reforms geared at improving Jamaica's business environment. The Council's efforts at improving the investment climate is driven by the reforms outlined in the Business Environment Reform Agenda (BERA). The BERA includes projects being implemented with other sources of funding by over 20 Ministries, Departments and Agencies (MDAs) in a comprehensive process of reprioritization, re-engineering and reform.
