The Government of Jamaica has received funding from the Caribbean Development Bank (CDB) in the amount of US\$9,418,370 towards the cost of the Basic Needs Trust Fund Tenth Cycle (BNTF 10). The Jamaica Social Investment Fund, as the executing agency, intends to apply part of the proceeds of this Grant to cover payments under contract for Design and Supervision Services for the following:

Consultant Firm for Design & Supervision of Georgia Rural Feeder Road, St. Thomas (#73756)

Scope: The project will involve the rehabilitation of 1.6km of roadway to include the sub-base, base course and wearing surface along with the construction of the associated kerb and channel and other drainage system to preserve the roadway from untimely degradation. The design should include retaining infrastructure to prevent further undermining of the roadway by the Dry River. Considerations should be given to the entrances to the properties along the road and the construction of retaining walls to maintain structural integrity where necessary.
