SCOPE OF WORK: The Contractor(s) will be required to undertake the rehabilitation of road pavements inclusive of but not limited to asphaltic double surface treatment, drainage improvement (culverts, kerb and channel), asphaltic concrete cross drains, surfacing and brushing of roadways.

Description of Service: The works comprise the complete construction and testing of approximately 6km of 600mm (24") nominal diameter Ductile Iron Transmission pipeline from the Old Pepper Well Site to the Gutters Relift Station, together with the provision for numerous appurtenances of stated Contract Specifications and Conditions, for the Greater Mandeville Water Supply Improvement Project – Phase 1B-7.
