#### INTRODUCTION

Housing Agency of Jamaica Limited (HAJL) intends to invite contractors to bid for the **Relocation of Sewer and Water Lines from Lots 94-105 at Green Pond (Phase 1), St. James.**

#### SCOPE OF WORKS

Contractors are expected to conduct, but are not limited to the following works:

1. Removal of potable water supply main from the affected lots.
2. Removal of sewer main from the affected lots.
3. Reinstallation of these infrastructures in the roadway.
4. Restoration of the road surface and sidewalk.
