In keeping with the Government's commitment to strengthen, promote and enhance the Public Procurement system, the Ministry of Finance and the Public Service (MOFPS), through the Office of Public Procurement Policy (OPPP), has officially mandated the use of the e-Procurement System for procurement transactions exceeding One Million, Five Hundred Thousand Jamaican Dollars (\$1,500,000.00), effective as of August 01, 2023. Suppliers interested in conducting business with the Government of Jamaica are now required to access and submit procurement documents through the Government of Jamaica Electric Procurement (GOJEP) system. The OPPP is providing continuous and dedicated support to suppliers, and is pleased to announce the commencement of its annual free virtual supplier training series for the 2023-24 financial year. All interested suppliers are encouraged to partake in this initiative. Virtual sessions will run from October 2023-February 2024.

These sessions are designed to empower participants with the knowledge and skills required to effectively support the navigating, administering and managing of the GOJEP system. Each session is four (4) hours in length, and integrates interactive discussions, covering topics such as supplier self-registration, electronic bid submission and supplier account management.

Scope

The Contractor will be required to undertake the following:

Removal of aggregate and existing pipes within the reed bed, installation of a new reed bed liner, pipes and new aggregate, flooding reed bed and planting of reeds, installation of flow meter monitoring devices and reinstallation of fence around reed bed.

Site Visit will be on **Tuesday, November 07, 2023.**

Bid Validity

Bids are valid for a period of **120 calendar days** after the Bid Submission Deadline.

Clarifications

All clarifications must be submitted through the e-GP System. Copies of all clarifications received will be available through the e-GP System. Requests for clarification should be received by the Procuring Entity no later than **seven (7) days** before the bid submission deadline.

Deadline for Submission of Proposals

Bids are to be uploaded to the GOJEP on or before **11:00 a.m. on Friday, November 17, 2023.** Any proposal received after the closing time for submission of proposals shall be rejected.

Tender Opening

The proposals shall be opened on the GOJEP at **11:15 a.m. on Friday, November 17, 2023.**

Description of Service: The works comprise the complete provision of labour, equipment, materials and management by the contractor to carry out roof replacement and associated works of stated Contract Specifications and Conditions at the National Water Commission's Engineering Department Building located at 4 Marescaux Road, Kingston 5.

Eligibility Requirements:

Tenderers must submit:

- A valid Tax Compliance Certificate (TCC)/valid Tax Compliance Letter (TCL) at the bid submission deadline
- A valid registration certificate from the Public Procurement Commission (PPC) in the following classification:
 - Roofing, Grade 2 Minimum OR
 - Building Construction, Grade 2 Minimum
- Completed, signed and sealed form of tender
- Bid security in the correct amount and form
- A Power of Attorney (POA) document is required if the Company's bid is not signed by a Director or Chief Executive Officer of the company.

Additional requirements are outlined in the Criteria used for evaluation in the Bidding Document.

Availability of Bid Document and Bid Submission: This is an online tender where tender documents, clarifications and bids will only be made available and accepted via the Government of Jamaica Electronic Procurement Portal–GOJEP (www.gojep.gov.jm). No offline (hard copies) will be accepted and there will be no physical tender drop-off of tender documents.

- Tender documents can be downloaded as of **Wednesday, October 25, 2023.**
- Clarification period – no later than 7 working days (**Monday, November 13, 2023**) before bid submission deadline.

Submission Deadline: Tenders must be submitted via the GOJEP no later than **Wednesday, November 22, 2023 at 11:00 a.m.**

Late bids will be automatically rejected by the system.

The original Bid Security MUST be submitted in hard copy to the Tender Box at the National Water Commission (NWC) delivered by **Thursday, November 23, 2023 at 11:00 a.m.** at the following address:
