- I. Examine the financial statements including statement of comprehensive income, statement of financial position, statement of cash flows and notes to the financial statements for 2018/2019, 2019/2020 and 2020/2021.
- II. Inspect, on a sample basis, documents supporting the disclosure and presentation of financial statements.
- III. Assess the internal controls and procedures with recommendations for improvement, where appropriate.
- IV. Provide review and verification of the University's accounts to ascertain compliance with the Government of Jamaica's established laws and regulations as well as compliance with IFRS standards.
- V. Evaluate the University's Procurement Standards to ensure they are in line with the Government of Jamaica Procurement Act, 2015.
- VI. Present any material findings in the financial statements, controls, and procedures by way of an exit meeting and management letter.
- VII. The external auditor will be required to perform fieldwork on both audit period simultaneously.
