Procuring Entity: The National Water Commission

Description of Service: The works comprises the Design - Build (and Operate) Works for the Rehabilitation and Upgrading of 3 NWC WWTPs located in Parishes of Portland (Woodstock WWTP), St. Mary (Stockholm WWTP) and St. Thomas (East Prospect) as per the Work Requirements inclusive of civil, electrical and mechanical works as stated in Contract Specifications and Conditions.

Eligibility Requirements:

Tenderers must submit:

- A valid Tax Compliance Certificate (TCC)/valid Tax Compliance Letter (TCL) at the bid submission deadline
- A valid registration certificate from the Public Procurement Commission in the following classification and valid at the bid submission deadline:
 - Civil Engineering, Grade 1
- Completed, signed and sealed form of tender
- Bid security in the correct amount and form
- A Power of Attorney (POA) document is required if the Company's bid is not signed by a Director or Chief Executive Officer of the company.

Applicants must prepare and submit responses as well as the forms that are contained in the RFP document. Additional requirements are outlined in the Criteria used for evaluation in the RFP document. Based on the results of the evaluation of the Technical Proposal, the shortlisted firms will be selected for opening of the Financial Proposals. The Financial Proposals will then be evaluated to identify the successful bidder.

The Financial Proposal and Technical Proposal should be submitted in two separate files on the GOJEP system.

Availability of Bid document and Bid Submission: This is an online tender where tender documents, clarifications and bids will only be made available and accepted via the Government of Jamaica Electronic Procurement Portal-GOJEP (www.gojep.gov.jm). No offline (hard copies) will be accepted and there will be no physical tender drop-off of tender

- Tender documents can be downloaded as of Wednesday, January 3, 2024.
- Clarification period no later than 7 working days (Monday, February 19, 2024) before bid submission deadline.

Submission Deadline: Tenders must be submitted via the GOJEP no later than Wednesday, February 28, 2024 at 11:00 a.m.

Late bids will be automatically rejected by the system.

The original Bid Security **MUST** be submitted in hard copy to the Tender Box at the National Water Commission (NWC) delivered by Monday, February 29, 2024 at 11:00 a.m. at the following address:
