The Government of Jamaica, through the Ministry of Health & Wellness, has received financing from the Inter-American Development Bank (IDB) towards the cost of the Support for the Health System Strengthening for the Prevention and Care Management of Non-Communicable Diseases Programme and intends to apply part of the proceeds for consulting services.

The consulting services ("the Services") are for a consulting firm to prepare and finalize appropriate detailed designs including the Bills of Quantities, technical specifications and budgets for the construction and rehabilitation of four (4) health facilities identified in Clarendon and St. Ann. Additionally, the consulting firm is to provide technical assistance services regarding the designs during the implementation of all engineering works and associated services for the four facilities as detailed in the Terms of Reference (TOR).

The Ministry of Health & Wellness now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. **The firm should meet the following criteria (i) At least ten (10) years of similar and/or relevant experience in managing/supervising construction projects with similar scope of works related to the preparation of bid documents including Bill of Quantities, technical specifications, architectural, structural and detailed engineering design. (ii) Must be able to provide eligible Key Experts that possess the requisite qualifications as per the Terms of Reference (TOR).**

Consultants will be selected in accordance with the International Competitive Bidding (ICB) procedures set out in the Inter-American Development Bank: **Policies for the Selection and Contracting of Consultants financed by the Inter-American Development Bank GN-2350-15** and is open to all eligible bidders as defined in the policies.

Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications. For the purpose of establishing the short list, the nationality of a firm is that of the country in which it is legally incorporated or constituted and in the case of Joint Venture, the nationality of the firm appointed to represent it.

A Consultant will be selected in accordance with the **Quality and Cost-Based Selection (QCBS)** method set out in the Consultant Policies.
