The Government of Jamaica has received a loan from the World Bank towards the cost of the SECOND RURAL ECONOMIC DEVELOPMENT INITIATIVE (REDI II) PROJECT. The Jamaica Social Investment Fund (JSIF) intends to apply part of the proceeds of this loan to cover payments under the following contract – **DESIGN & SUPERVISION OF OLD FORT CRAFT MARKET REHABILITATION – MONTEGO BAY, ST. JAMES.**

Scope: Consultancy to formulate and supervise the following works:

1. Construction/Upgrading of the 2 entrances to the facility to include columns with cut stone finish
2. Construction of an administrative office
3. Painting/Refurbishing of the entire facility
4. Rehabilitation of 4 restrooms
5. Provision of solar lightings mounted on existing poles
6. Retrofitting and furnishing of existing Gazebo to include fabric roll-up shutters
7. Provision of termite treatment for the facility
8. Electrical rewiring of the facility
9. Construction of 1 garbage skip.

Scope: Construction of 4.8km of PVC Transmission Force main and the installation of associated valves and fittings. Construction of 3km of high voltage Pole line, installation of a 2,500 gallon per minute (gpm) water pump and switch gear along with the retrofitting of a 40ft container for pump control room.
