PROJECT BACKGROUND:

The Judiciary is undertaking an islandwide upgrade to its facilities. A part of this initiative involves providing a secure and private space to cater to its users. Against that background, the CAD would like to procure soundproof kiosks (Remote Court Privacy Pods) for the courts. These kiosks will be fitted with telephones and internet connectivity to help improve the channels of communication between lawyers and their clients.

ELIGIBILITY REQUIREMENTS (DOMESTIC BIDDERS):

1. Tax Compliance Certificates or Tax Compliance letter clearly showing the expiration date.
2. Copy of valid Public Procurement Commission Registration in either of the following categories:
 - Information Technology Services
 - Information Technology Systems
 - Computer and Related ServicesOr any other relevant categories.

ELIGIBILITY REQUIREMENTS (INTERNATIONAL BIDDERS):

Public Procurement Commission Registration is not a requirement to participate in the process. However, if a foreign Bidder is successful, the Bidder is required to register before the contract can be awarded.

The National Works Agency (NWA) invites sealed bids from eligible and suitably qualified contractors for the procurement of **ST JAGO – PUSEY HILL, MANCHESTER / MINISTRY OF ECONOMIC GROWTH AND JOB CREATION – MAINTENANCE OF SECONDARY ROADS – F/Y 2023/2024**

Scope of Works: The work consists of but not limited to Demolition, Site Clearance & Drain Cleaning, bushings, trimming of banks, cutting of overhanging trees, concrete pipe culvert, concrete u drain, cross drain construction, base course, prime coat, asphaltic concrete overlay (38 mm thick), asphaltic concrete patching (38 mm thick), rubble masonry retaining wall, and rubble masonry parapet wall.
