**Procuring Entity:** The National Water Commission

**Description of Service:** The works consists of the execution of Phase 1E of the Eltham Waste Water Treatment Plant Rehabilitation & Upgrade Project Which Involves Restoration of Drying Beds and Digester at the Eltham Wastewater Treatment Plant (WWTP) St. Catherine, together with other minor civil works as stated in Contract Specifications and Conditions.

#### Eligibility Requirements:

Tenderers must submit:

- A valid Tax Compliance Certificate (TCC)/Tax Compliance Letter (TCL) at the bid submission deadline
- A valid registration certificate from the Public Procurement Commission, valid at the bid submission deadline in the following classification:
  - Building Construction, Grade 2 minimum OR
  - Civil Engineering Works, Grade 2 minimum
- Completed, signed and sealed form of tender
- Bid security in the correct amount and form
- A Power of Attorney (POA) document is required if the Company's bid is not signed by a Director or Chief Executive Officer of the company.

Additional requirements are outlined in the Criteria used for evaluation in the Bidding Document.

#### Availability of Bid Document and Bid Submission:

This is an online tender where tender documents, clarifications and bids will only be made available and accepted via the Government of Jamaica Electronic Procurement Portal – GOJEP ([www.gojep.gov.jm](http://www.gojep.gov.jm)). No offline (hard copies) will be accepted and there will be no physical tender drop-off of tender documents. Tender documents can be downloaded as of **Wednesday, March 27, 2024.**

**Clarification period** – no later than 7 working days (**Monday, April 22, 2024**) before bid submission deadline.

**Submission deadline:** Tenders must be submitted via the GOJEP no later than **Wednesday, May 1, 2024 at 11:00 a.m.** Late bids will be automatically rejected by the system.

The original Bid Security **MUST** be submitted in hard copy to the Tender Box at the National Water Commission (NWC) delivered by **Thursday, May 2, 2024 at 11:00 a.m.** at the following address:

### INVITATION TO BID FOR Security Services (CPFSA-2024-15)

The Child Protection and Family Services Agency – CPFSA (formerly Child Development Agency) – invites bids from Tax Compliant Companies registered with the Public Procurement Commission (PPC) & the Private Security Regulation Authority (PSRA) to provide security services. The services are for static guard for three years. The services will be for Residential Child Care Facilities and offices of the CPFSA across the island.

#### Eligibility

Interested companies must submit proof of current tax compliance (TCC/TCL), proof of Registration with the Public Procurement Commission (PPC) as a provider of Safety and Security Services and proof of registration with the Private Security Regulation Authority (PSRA).
