Consumers Welcome Increase in Duty-Free Threshold

HE GOVERNMENT'S decision to increase the duty-free threshold on imported personal items has been welcomed by local consumers.

Effective April 1, 2024, the de minimis value for imported goods increased from US\$50 to US\$100.

"For me to import stuff here and keeping it under US\$50, it has been taking a toll on me. So, having it under US\$100, I can order more stuff and keep it at that limit... So, I really love that it has increased..."

In announcing increase in the threshold, Minister of Finance and the Public Service, Dr. the Hon. Nigel Clarke said, "the measure aims to facilitate access to a wider variety of goods by local consumers and stimulate business in the local economy as shipping companies and intermediaries capitalise on the increased activity".

He made the announcement during his budget debate presentation in March.

Meanwhile, entrepreneurs have been lauding the implementation of the measure.

Entrepreneur, Lawman, who imports items for sale, tells JIS News that the increase in the duty-free threshold is welcome.

"For me to import stuff here and keeping it under US\$50, it has been taking a toll on me. So, having it be under US\$100, I can order more stuff and keep it at that limit, and I don't have to pay the weight cost in parts. So, I

She notes that "US\$50 was not sufficient [based on current prices], so I think she can now freely shop for

For items under US\$100, I no longer pay the heavy customs fees; I am able to just focus on the weight of the items. So, it has helped in my budgeting," she tells JIS News.

She says further that

items that are not available locally and "it increases my options of where I can shop".

Brian Anderson, a 24year-old Content Creator from Morant Bay, who specialises in videography and photography also welcomes the increase.

He generates content about the parish of St. Thomas for his YouTube page, Eastside Media, which has an audience of nearly 8,500 subscribers.

"We (content creators) will benefit more because we can ship in more items. Normally, when I am shipping equipment and it costs over US\$50, I have to worry about customs, and the equipment we use are hard to source for below that price. With the increase, I can add more things to my cart, and I can more comfortably pursue my passion," he states.

## Shipments Exceeding US\$100 will Attract Full Duty

THE JAMAICA Customs Agency (JCA) is reminding persons bringing personal items into Jamaica that attract customs charges on the full declared value

"For example, should a shipment be declared with a value of US\$101, duty will be calculated on the full amount, not just the excess of US\$1," the JCA said.

In a post to X, formerly Twitter, the JCA also urged the public to familiarise themselves with Customs policies and import procedures to ensure smooth and efficient clearance of imported goods.

Meanwhile, Prime Minister the Most Hon. Andrew Holness noted that the increase in the threshold was possible, as the Government has created a stable and robust macroeconomic environment of fiscal certainty, which supports employment and income generation, capital invest-

> ment, and increased economic activity. This, he said, has allowed the Government to actively reduce the tax burden on the people of the country.
