The Office of the Prime Minister (OPM), acting on behalf of the Government of Jamaica (hereinafter called “Borrower”), has received financing (hereinafter called “funds”) in the amount equivalent to US\$68,000,000.00 from the Inter-American Development Bank (hereinafter called “the Bank”) towards the cost of the implementation of 4437/OC-JA – National Identification System (NIDS) Project. The Borrower intends to apply a portion of the funds to eligible payments under the contract for the upgrade/improvement of the Government’s Information and Communications Technology Infrastructure. Payments by the Bank will be subject in all respects to the terms and conditions of the Loan Contract. Payments will be made only at the request of the Borrower and upon approval by the Bank in accordance with the terms and conditions of the financing contract between the Borrower and the Bank. No party other than the Borrower shall derive any rights from the Loan Contract or have any claim to the funds.

The OPM now invites bids from eligible bidders for **Renovation of Spaces – Brown’s Town Spanish Town and Greater Portmore Enrolment Sites**. Bidding will be conducted through National Competitive Bidding procedures as specified in the Inter-American Development Bank’s *Policies for Procurement of Works and Goods financed by the Inter-American Development Bank* (GN-2349-9), and is open to all eligible bidders as defined in the policies.

ELIGIBILITY

The successful Bidder, at the time of contract award, must possess a valid Tax Compliance Letter (TCL) and be registered with the Public Procurement Commission (PPC) in the Building Construction category as follows:
One (1) Lot – (Grade 2 minimum)
Two (2) or more Lots – (Grade 1)

NB: Interested bidders are strongly encouraged to commence the registration processes during the tender period to minimize delays with contract execution upon receiving contract award notification.

ANN – MINISTRY OF ECONOMIC GROWTH & JOB CREATION -MAINTENANCE OF SECONDARY ROADS - F/Y 2024/2025**

Scope of Works: The works consist of but not limited to bushing, trimming of banks, cutting of overhanging trees, removal of all silt, debris, obstructions to free flow conditions, general excavation, disposal engineered fill, compact bottom trench, grade 400 deformed type 2 steel bars to JS33:2005, asphaltic concrete cross-drain, cement and sand (1:3) rendering, rubble masonry parapet wall and coping.
