EXCLUSIVE USE OF THE GOVERNMENT OF JAMAICA ELECTRONIC PROCUREMENT (GOJEP) SYSTEM

In keeping with the Government's commitment to strengthen, promote and enhance the Public Procurement system, the Ministry of Finance and the Public Service (MOFPS), through the Office of Public Procurement Policy (OPPP), has officially mandated the use of the e-Procurement System for procurement transactions exceeding One Million, Five Hundred Thousand Jamaican Dollars (\$1,500,000.00), effective as of August 01, 2023. Suppliers interested in conducting business with the Government of Jamaica are now required to access and submit procurement documents through the Government of Jamaica Electronic Procurement (GOJEP) system. The OPPP is providing continuous and dedicated support to suppliers, and is pleased to announce the commencement of its annual free virtual supplier training series for the 2023-24 financial year. All interested suppliers are encouraged to partake in this initiative. Virtual sessions will run from October 2023-February 2024.

These sessions are designed to empower participants with the knowledge and skills required to effectively support the navigating, administering and managing of the GOJEP system. Each session is four (4) hours in length, and integrates interactive discussions, covering topics such as supplier self-registration, electronic bid submission and supplier account management.

PROCUREMENT OF SOY-BASED INFANT FORMULA

The Government of Jamaica, Ministry of Health & Wellness, now invites bids from eligible and qualified companies for the Supply and Delivery of Soy-Based Infant Formula over a Two (2) Year period.

Bidding will be conducted through the National Competitive Bidding (NCB) Procedures specified in the Government of Jamaica Handbook of Public Sector Procurement Procedures.

Eligibility Requirements:

Bidders must submit the following with their bids at the time of bid submission:

- Valid Copy of Public Procurement Commission (PPC) Registration in the category specified in the bidding document.
- Valid Copy of Tax Compliance Letter/Tax Compliance Certificate/(TCL/TCC)

NB – All certificates submitted must display the expiration dates.

Bid submissions that do not comply with all the above requirements will be deemed non-responsive.

Availability of Bid Documents and Bid Submission:

This is an online tender where tender documents, clarifications and bid submission will only be made available and accepted via the Government of Jamaica Electronic Portal – GOJEP (www.gojep.gov.jm). No offline (hard copies) will be accepted and there will be no physical drop box for drop-off of tender documents.

- Clarification period ends – **Monday, August 5, 2024.**

Submission Deadline:

Tenders must be submitted via the GOJEP no later than **Monday, August 12, 2024 at 10:00 a.m. local time.** Late bids will be automatically rejected by the system.
