Householders Receiving Grants Under 'Rebuild Jamaica'

started to receive grant assistance under the Government's 'Rebuild Jamaica' initiative. A sum of \$1 billion has been allocated to enable persons impacted by the passage of Hurricane Beryl on July 3, to recover and rebuild.

Under the programme, persons whose houses were destroyed will receive grant funding of up to \$400,000; those whose homes were severely damaged will receive \$150,000; and those who experienced minor damage will receive \$50,000.

Prime Minister, Dr. the Most Hon. Andrew Holness, said the prudent management of the country has enabled the Administration to respond to and provide relief and recovery assistance.

He noted that the Government has so far allocated over \$5 billion to relief and recovery, in addition to insurance funds.

Minister of Labour and Social Security, Hon. Pearnel Charles Jr., in providing details about the assistance being provided under 'Rebuild Jamaica,' said that to

> He informed that of the total assessment, a little more than 7,000 have been validated and all cheques printed at a value of \$646.250 million.

> "Of those cheques which have been distributed, to date, based on average across the parishes, more than 80 per cent of our beneficiaries [have] received those cheques," he stated.

> He said that the Ministry will be hosting a series of community meetings to address challenges in validating some of the information provided by persons, and urged householders, whose houses were damaged and who were not assessed to also attend these meetings "and we will take your information and ensure that we get your assessment done."

Mr. Williams, who lost the roof on his house, said the grant will significantly aid in rebuilding efforts.

For his part, James Barrett of Golden-Valley said, "The category four hurricane affected me very badly because the house blew over and an ackee tree

dropped in it and split it up." He told JIS News that his furniture and appliances were destroyed, and he is grateful for the assistance from the Government to help him recover.

Government Partners with International Stakeholders

A PARTNERSHIP involving the United Nations (UN) World Food Programme (WFP) and United Nations Children's Fund (UNICEF) has facilitated the provision of financial support to persons whose homes were either destroyed or rendered uninhabitable.

Minister Charles Jr. said this financial relief is being disbursed in phases to ensure accuracy and timeliness.

"The UN World Food Programme has provided \$219 million in cash grants for 3,400 of the worst affected households. These are families with young children (0-6 years old), persons with disabilities and elderly members. Over 11,500 individuals will receive that support," he indicated.

Mr. Charles Jr. said that the payments are being disbursed in two tranches over a period of two months, through Western Union.

The first half of these funds was paid out between September 12 and 13, with the

second tranche slated to be dispatched to the same beneficiaries in October.

Mr. Charles Jr. said that under a second partnership, UNICEF has provided \$42.75 million in support for 7,000 households in the parishes of St. Catherine, Clarendon, Manchester and St. Elizabeth.

Of this amount, \$36.5 million has been designated for families on the Programme of Advancement Through Health and Education (PATH) with children ages zero to six years and pregnant/lactating women,

and a further \$6.25 million for persons with disabili-

"I can confirm that disbursal of funds under the UNICEF partnership commenced on September 16." the Minister said.
