The Government of Jamaica/Ministry of Labour & Social Security has received financing from the World Bank towards the cost of implementing the Social Protection for Increased Resilience and Opportunity (SPIRO) Project and intends to apply part of the proceeds for consulting services for the **IT Assessment of Jamaica's Public Employment Services.**

**Objective of the Consultancy:** The Consultancy will have two primary tasks:  
1) assessing Jamaica's IT systems for providing Employment Services; and 2) developing a technical proposal that maps current ("as is") IT systems and processes and defines needs for enhanced IT systems and processes to meet the requirements of strengthened and expanded Employment Services. The focus of these tasks will be MLSS's four main Employment Service functions (labour market intelligence, job matching, career and skills guidance, referrals) and the case management, monitoring and evaluation, performance management, and grievance redress processes that support delivery across these functions. All tasks will be undertaken in close consultation with MLSS and in coordination with a parallel consultancy undertaking a functional assessment of Employment Services.

**Duration of the Consultancy:** The Consultant is expected to work for an estimated 50 business days over nine (9) months. If not located in Jamaica, the Consultant will be expected to travel to Jamaica on mission(s) to meet with stakeholders, gather information, and hold the required workshop.

**Selection Method:** Individual Consultant Selection Method as set out in the Procurement Regulations. The evaluation will be based on academic, technical expertise and work experience as detailed in the Terms of Reference.

**EXCLUSIVE USE OF THE GOVERNMENT OF JAMAICA ELECTRONIC PROCUREMENT (GOJEP) SYSTEM**

In keeping with the Government's commitment to strengthen, promote and enhance the Public Procurement system, the Ministry of Finance and the Public Service (MOFPS), through the Office of Public Procurement Policy (OPPP), has officially mandated the use of the e-Procurement System for procurement transactions exceeding One Million, Five Hundred Thousand Jamaican Dollars (\$1,500,000.00), effective as of August 01, 2023. Suppliers interested in conducting business with the Government of Jamaica are now required to access and submit procurement documents through the Government of Jamaica Electronic Procurement (GOJEP) system. The OPPP is providing continuous and dedicated support to suppliers, and is pleased to announce the commencement of its annual free virtual supplier training series for the 2023-24 financial year. All interested suppliers are encouraged to partake in this initiative. Virtual sessions will run from October 2023-February 2024.

These sessions are designed to empower participants with the knowledge and skills required to effectively support the navigating, administering and managing of the GOJEP system. Each session is four (4) hours in length, and integrates interactive discussions, covering topics such as supplier self-registration, electronic bid submission and supplier account management.
