## INVITATION TO BID

The Government of Jamaica established the Jamaica Social Investment Fund (JSIF) to assist in its poverty eradication programme. The Jamaica Social Investment Fund (JSIF) has signed an MOU with the Rural Water Supply Limited for the implementation of their Rainwater Harvesting Projects. JSIF will provide project management functions required for the construction and installation of a 400-gallon water tank at each household. The Jamaica Social Investment Fund intends to use part of the proceeds of this agreement to cover payments under the following contracts:

The Jamaica Social Investment Fund now invites bids from eligible and qualified bidders for the **National Drought Mitigation Project – Cluster 1, Cluster 2 and Cluster 3** as follows:

**PLEASE NOTE THAT EACH OF THE ABOVE CLUSTERS ARE SEPARATED IN LOTS. NO BIDDER WILL BE ELIGIBLE FOR AN AWARD OF CONTRACT FOR MORE THAN A MAXIMUM OF TWO LOTS FOR CLUSTERS 1 & 2 AND MAXIMUM OF THREE LOTS IN CLUSTER 3.**

As such, a bidder who is awarded the maximum number of Lots in Cluster 1 will be eliminated from further consideration in Cluster 1. The same elimination process will be used for Cluster 2 and Cluster 3.
