EXCLUSIVE USE OF THE GOVERNMENT OF JAMAICA ELECTRONIC PROCUREMENT (GOJEP) SYSTEM

In keeping with the Government's commitment to strengthen, promote and enhance the Public Procurement system, the Ministry of Finance and the Public Service (MOFPS), through the Office of Public Procurement Policy (OPPP), has officially mandated the use of the e-Procurement System for procurement transactions exceeding One Million, Five Hundred Thousand Jamaican Dollars (\$1,500,000.00), effective as of August 01, 2023. Suppliers interested in conducting business with the Government of Jamaica are now required to access and submit procurement documents through the Government of Jamaica Electronic Procurement (GOJEP) system. The OPPP is providing continuous and dedicated support to suppliers, and is pleased to announce the commencement of its annual free virtual supplier training series for the 2023-24 financial year. All interested suppliers are encouraged to partake in this initiative. Virtual sessions will run from October 2023-February 2024.

These sessions are designed to empower participants with the knowledge and skills required to effectively support the navigating, administering and managing of the GOJEP system. Each session is four (4) hours in length, and integrates interactive discussions, covering topics such as supplier self-registration, electronic bid submission and supplier account management.

The Child Protection and Family Services Agency, (CPFSA) formerly Child Development Agency, invites bids from Tax Compliant Companies registered with the Public Procurement Commission (PPC) & the Private Security Regulations Authority (PSRA) to provide security services. The service is for static guard for one (1) year. The service will be for offices of the CPFSA across the island.

Eligibility

Interested companies must submit proof of current tax compliance certification in that of a Tax Compliance Letter and proof of Registration with the Public Procurement Commission (PPC) as a provider of Safety and Security Services. Interested companies must also present proof of registration with the Private Security Regulations Authority (PSRA).

Bid Documents will be available from **Tuesday, October 22, 2024** online at www.gojep.gov.jm Bids will be submitted online, there will be no physical collection of bid documents.

Bid Security

A bid security of Five hundred thousand dollars (\$500,000.00) will be required in managers' cheque or bond which must be submitted with the bid documents electronically. The hardcopy of the bond or cheque is to be submitted to the CPFSA within two business days following submission.

Bids must be submitted online via GOJEP portal at www.gojep.gov.jm **no later than November 14, 2024 at 2:00 p.m.**

Bids will be opened online via www.gojep.gov.jm the GOJ procurement online platform on **November 14, 2024 at 2:15 p.m.** An online bid report will be sent to all bidders.
