**Procuring Entity:** The National Water Commission

**Description of Service:** Electrical Works – For the operation of two (2) new high-pressure centrifugal pumps with electrical supplies for Gutters Pumping Station, Manchester, guided by the stated Contract Specifications and Conditions.

**Scope of Works:** The objective of this project is to do Road Rehabilitation of a section of Wickie Wackie with asphaltic concrete 38mm thick. Preparatory works include scarifying of existing surface and carting away of spoils. The construction of new limestone base grade, wet and compact to receive asphaltic concrete as directed.
