Procuring Entity: The National Water Commission

Description of Service: Electrical Works – For the operation of two (2) new high-pressure centrifugal pumps with electrical supplies for Gutters Pumping Station, Manchester, guided by the stated Contract Specifications and Conditions.

Eligibility Requirements:

Tenderers must submit:

- A valid Tax Compliance Certificate (TCC)/Tax Compliance Letter (TCL) at the bid submission deadline
- A valid registration certificate from the Public Procurement Commission, valid at the bid submission deadline in the following classification:
 - Electrical Works, Grade 2 minimum**
- Completed, signed and sealed form of tender
- Bid security in the correct amount and form
- A Power of Attorney (POA) document is required if the Company's bid is not signed by a Director or Chief Executive Officer of the company.

Availability of Bid Document and Bid Submission: This is an online tender where tender documents, clarifications and bids will only be made available and accepted via the Government of Jamaica Electronic Procurement Portal – GOJEP (www.gojep.gov.jm). - Clarification period – no later than 7 working days (**Monday, December 9, 2024**) before bid submission deadline.
