The National Insurance Fund (NIF), Ministry of Labour and Social Security, invites contractors registered with the Government of Jamaica Electronic Procurement (GOJEP) platform to submit tenders to Provide Architectural Design Services for the Commercial Building Complex and NIS Flagship Office in May Pen, Clarendon.

#### DESCRIPTION OF WORKS:

- The Scope of Works includes, but is not limited to:
- Schematic Design Phase: prepare preliminary architectural designs for the commercial business complex, prepare a preliminary cost estimate based on preliminary design, provide detailed activity schedule for the Architectural Services, and submit any further recommendations for concept designs.
- Design Development Phase: incorporate requested modifications to revise schematic design, to secure client approval of the architectural designs, revise cost estimates, submit preliminary construction schedule and assist in submission of applications for outline approvals from Statutory Bodies.
- Contract Documents Phase: assist in submission of applications for full building approvals from Statutory Bodies and other interested parties, prepare the schedules, specifications and other tender documents that are necessary to enable the NIF to obtain tenders or otherwise award a contract for the construction of the facility.
- Negotiation/Evaluation Phase: to serve on the evaluation committee to provide technical analysis/evaluation and respond to queries or technicalities related to architectural services.
- **Project Implementation Phase:** to perform periodic inspection, technical support, conduct testings, monitoring of the execution of works to ensure compliance with design, to attend site/ stakeholder/quality control meetings, and to serve as an integral part of the project team.

The Tender Document will be available on the Government of Jamaica Electronic Procurement (GOJEP) platform.

#### **ELIGIBILITY FOR TENDER:**

National Competitive Bidding (NCB) Procurement Method will be used and tenderers must submit the following along with their bids:

- Inclusion of all items in the Bid Submission Checklist (Page 9 of the Tender Document).
- Proof of licence to practise with the Architects Registration Board (ARB)
- A valid Tax Compliance Certificate (TCC).

Non-compliance with any of the above criteria will result in disqualification.

Proposals must be submitted online via the GOJEP platform on or before Monday, January 13, 2025 by 3:00 p.m. (15:00 hours).
