INVITATION TO BID INTERNATIONAL COMPETITIVE BIDDING

PROCUREMENT FOR THE DEVELOPMENT AND IMPLEMENTATION OF AN ELECTRONIC IMMUNIZATION REGISTRY (EIR) SOFTWARE

The Ministry of Health & Wellness (MOHW) is seeking proposals from qualified vendors for the development and implementation of an electronic immunization registry (EIR)

BACKGROUND

The Ministry of Health & Wellness (MOHW) working in collaboration with the United Nations Children's Fund (UNICEF), the Pan American Health Organization (PAHO), United States Agency for International Development (USAID) and other local partners, is the lead partner in the planning and implementation of a standards-based, interoperable EIR system in health facilities across the country.

The EIR Project builds on the Jamaica COVID-19 vaccine delivery mobile application system (based on CommCare) launched in 2021 to digitize dosage tracking of COVID-19 vaccines, with real-time access to vaccination and adverse event data to support pandemic response efforts. The successes and learnings from the COVID-19 vaccination delivery mobile application highlighted the need for access to disaggregated, accurate, complete and timely information to achieve strategic business objectives. In early 2023, an EIR Readiness Assessment was conducted. It reviewed investments and Information Systems for Health (IS4H) plans, the current landscape of the immunization programme including data and systems. Recommendations for digitizing the immunization programme were provided. Following the assessment, a convergence workshop was held to review findings, confirm the objectives and collaboratively plan for the implementation of the EIR.

The primary objective of the consultancy is to develop and implement phase one of a state-of-the-art EIR system across 18 pilot sites in Jamaica that improves the efficiency, accuracy, accessibility and use of immunization data.

ELIGIBILITY CRITERIA

- Valid Tax Compliance Certificate – The successful company will be required to submit a valid Tax Compliance Certificate prior to contract award.
- Bid Security in the amount of US\$2,000.00 or J\$320,000.00 is required.

Additional requirements are outlined in the Bidding Document.

This is an online tender where tender documents, clarifications and bids will only be made available and accepted via the Government of Jamaica Electronic Procurement Portal – GOJEP (www.gojep.gov.jm).
