Eligibility Requirements

Interested firms **MUST** provide documentation demonstrating that they have met the required eligibility criteria as follows at time of bid submission:

- Valid Tax Compliance Letter (TCL)
- Evidence of practice in Jamaica by both the Institute of Chartered Accountants of Jamaica and the Public Accountancy Board
- Certificate of Registration with the Institute of Chartered Accountants of Jamaica
- Any other requirement as outlined in the bidding document.

All documents above must be submitted at the time of bid submission. Non-compliance with any or all of the above will result in automatic disqualification of tender.

A complete set of Bidding Documents in English were made available for download as at **December 23, 2024** on the Government of Jamaica Electronic Procurement website at www.gojep.gov.jm. Bidders **MUST** be registered on the GOJEP system in order to access the bidding documents and participate in the tender. Registration can be done by following the instructions listed on the website at www.gojep.gov.jm. Bids shall be valid for a period of **120 days** after bid closing date.

Bid Submission & Opening:

Bids must be submitted online via in the Government of Jamaica Electronic Procurement website at www.gojep.gov.jm no later than **2:00 p.m. on Monday, January 27, 2025**. Online Bid Opening will take place at **2:30 p.m.** on the same date. An Online Bid Opening Report will be sent to all bidders. The system will automatically reject late Bids.
